III. Board Reports

President- Dana Sumrow

- O RID National Conference-
- Attended the national conference, very successful and rewarding experience
- Some member service issues (i.e. dealing with national office is generally troublesome)
- Regional meeting- very productive; worked on establishing a procedure for using Region IV funds
- NMRID Caucasus (at the nat'l meeting)
 - Mixed reviews from members, some felt it was generally dry
 - Members from southern part of the state feel that NMRID doesn't meet their needs, e.g., they feel closer to Texas RID in that there are more workshops, conferences etc literally closer to them, El Paso etc
 - O Dana suggested to them web casting or other technology based solution, but this was not positively received
 - Heather suggested keeping an eye out for potential representatives from the smaller communities (Clovis, Farmington etc) ***Perhaps an open call for reps through list serve**

General Membership Complaint-

O Dislike the use of the list serve by WeInterpret. Dana has already addressed the issue; this is a community list serve. If the membership wishes to change it from community accessible to only NMRID accessible they may attend the general membership meeting in December and make a motion to change its status.

O The Board requests that Dana forward this response to them; also the Board requests that Dana cc them on her responses to pertinant emails so that we can not only standardize our responses to these issues, but generally all be on the same page.

- RLD has issued to date; 91 community licenses, 2 educational licenses, 35 provisional licenses
- Tentative date for the next Licensure Board meeting is November 9th, 2009
- Exceptions: Some exceptions have arisen that require the Board to make a determination about granting a license to the applicant. These applicants have applied prior to the deadline (October 19) but won't be issued a license until after the Board meeting. These people *have* met the requirement of applying for their license, thus they should be permitted to continue working until after the next Board meeting. Lisa Dignan will be sending a memo for employers of these applicants with that information.
